## **2022 Training**

This year, after two years of COVID lockdown, we held four (4) in-person training sessions throughout the state. Some sessions were better attended then others, overall, we had about 150 or so participants. Given the current climate of COVID, staffing shortages, budget constraints, etc. WHAIC will host one virtual session on November 17<sup>th</sup> from 9:00am-11:00am CST.

Each facility is responsible for compliance with discharge data submission and must adhere to the State Statutes and calendar timelines. Understanding the data submission process is important. Wisconsin 'WIpop' data collection is based on a modified HIPAA Compliant 837 claim file format. The discharge data submission manual will be reviewed along with the process to sign off on the data and affirm its accuracy. WHAIC collects data pursuant to <a href="Chapter 153">Chapter 153</a> of the State Statutes and the requirements as outlined in the Administrative Rule <a href="DHS 120">DHS 120</a>.


In 2023, the data collection process will include more emphasis on better collection of more than one race, language, and reporting the NAIC # or Payer identification (ID) on the EDI file sent to WHAIC. WHAIC released the mapped payer name in the datasets in Q122; however, to fully capitalize on the value of the payer data,

we need more confidence in our delivery of this data by validating and running comparisons of the Payer ID / NAIC # and actual payer name to the mapped payer data.

The Payer ID is a unique ID assigned to each insurance company. It allows provider and payer systems to talk to one another to verify eligibility, benefits and submit claims. The Payer ID is generally (5) characters. The Payer ID should be provided on the patient's insurance card and included on the 837claim file.

This information is currently collected by EHRs, practice management systems, registration systems, payer systems, pharmacy systems, etc., basically any systems that participate in the delivery and billing of payers for patient care. Collecting and reporting this field should cause minimal disruption to the verification of it in the file since it's already required when exchanging billing information with the clearinghouse, payer, or other administrative functions to obtain payment.

The Payer ID may be on the front or the back of the card. Please be sure to share this with the appropriate person(s) in your organization to satisfy the reporting requirements.
