We encourage you to speak with your team members, supervisors, and others to attend one of the four in-person sessions. Although there is some benefit in hosting virtual trainings (which we have not planned at this time), we feel in-person training allows us to have a more connected experience and gives you the opportunity to interact, ask questions and create a more positive experience in the data submission process.

WIPop Updates:

Place of Service Update: Effective with **Q322**, WHAIC has moved the (former) observation revenue code 0760 to the place of service 6 – Other Outpatient Hospital Data. The only revenue code that will be counted as true observation will be revenue code 0762.

Payer mapping: Effective with **Q222** discharge data submissions, several new edits have been implemented to the payer codes that have been discontinued/eliminated since January 2021. Hence, it's imperative that the mapping is regularly reviewed and updated accordingly. Also, be sure to review the mapping of health plans that are no longer in business and/or transitioned to other payers such as Physicians Plus, Aspirus, and Gundersen Health plan to the appropriate respective categories as per the [Appendix 7.3](#).

Payer Update: Effective with **Q122** discharge data release, the name of the mapped payer will be included in the data. Once the payer mapping is included in the data release, I may be contacting facilities for clarification on payer mapping if needed. And, of course, once we release the data, it often leads to new suggestions, ideas, and request for a bit more mapping modification. Please be patient and we ask for understanding with us as we try to refine our datasets.

2023 Potential Data Focus: Mode of arrival, Marital Status, Language, inclusion of ICD-10 codes for Social Determinants of Health (SDoH) and of course continuing to monitor/update payer mapping.
